#### 1. Minutes of the BoD meeting held September 27, 2016

Munir moved acceptance of the minutes, seconded by Kabir, approved unanimously.

#### 2. 2016 Financial Reports YTD to end of October

were presented for information, with the following commentary:

- The accounts receivables figure was partly explained in relation to the Regional fees since received (UK fees, \$2184) or anticipated shortly (VDN, \$1080).
- the surplus in funds arises in part from reduced payroll costs (changes in staffing costs compared to last year) and donations received above budgeted levels.
- while a modest surplus is prudent, a review of staff salaries could be included in the forthcoming budget planning for 2017.
- it is assumed we will not need to draw on the prior year revenue for the fee support fund, as our net income remains above budget.
- A bequest is anticipated from the generosity of Rosina Horeth: this may be finalized in 2017.
- an analysis of the fee support for the year to date was presented:

The increase in fee support in 2016 may be explained in part by increasing take-up of the support, particularly in Russia, and in part by the increase in fees to be supported (now \$36.) It was noted in discussion that our policy is to grant fee support on application, not automatically to dance leaders in specific countries.

# 3. Executive Director's report

I am adding to Facebook articles from the most recent newsletter. I am seeking translation into Russian for the next newsletter.

I am working with Bruce to get a prompt on My Info for mobile phone numbers and an opt-out if people do not wish to give their mobile phone numbers.

So far, we know of 27 mobile phone numbers, though many North American numbers which we hold may be mobile numbers.

#### Appeal donations:

We received an anonymous donation of \$2000 in May. Our recent request for donations to the fee support fund has resulted in donations totaling \$470 from 5 individuals.

I attended the Jamiat Khas at The Abode, NY in early November, and this was very useful as an opportunity to dance with leaders from North America, Ecuador and elsewhere, and a delight to meet Munir and Kabir for the first time. It was helpful to be able to work on plans for engagement with Russian dance leaders, with the help of Abraham and Halima Sussman and Aliela Gorzaltchik.

We have put a link on the website for youth, and Arjun is helping with engagement with young dance leaders.

On the website, I am working to update the contact list for each country, complete some missing colorization, and extend Dutch and Portuguese translations.

Looking ahead, I want to work country by country to understand the current dance activity and number of leaders in each area.

#### Noted in discussion:

- news items should appear in the newsletter before being posted to Facebook
- it may not be possible to identify in Latin America which phone numbers are mobile phone numbers: Aziz will explore this with Arjun.

## 3. Guidance Council report

Guidance Council met in person at the Jamiat Khas in November. They were interested to know the impact of the updated Leader Guidelines in terms of spiritual deepening in dance leading. It is not easy to assess this except face to face, but the general sense is that this is occurring.

The role of mentors in the transmission and inspiring leaders to join the Leaders Guild was emphasised, and this is very apparent in Latin America.

We received feedback that Sufi Ruhaniat International appreciated the spread of languages in which DUP IN operates.

#### **5.** Goals and activities

The Board was invited to review the <u>goals and activities for 2016</u> in light of progress reported to the Board, as the basis for identifying goals and activities for 2017. Noted in discussion:

- increase the number of dance write-ups in more of the languages we support eg we know of more dances in Russian and German, we should seek others.
- continue to seek translation of the Foundation Manual into German
- obtain feedback at camps on our activities, priorities and plans again, as we did a few years ago, set up a round of presentations by BoD members at camps to share with

leaders what DUP IN is doing (activities, priorities, plans) and receive as well their feedback and suggestions.

- communication: consider focus groups to understand how we can best communicate across our dance leader family. This may involve waiting with the next general newsletter, and focusing initially on a Russian language newsletter which better explains what is on offer and how DUP IN supports the transmission of the dances.
- we could consider further teleconferences for mentors and leaders
- the recent advanced leader training led by Darvesha and Munir indicated that leaders are hungry for spiritual deepening in dance leading. Munir could consider writing a piece on the training.

#### 6. Dates of future BoD meetings (2017):

The following dates for Board meetings and the Annual meeting were agreed, with the Admin Committee meeting the week before the Board meeting. Board meeting dates are in bold below.

We also agreed that the meetings will start two hours earlier than at present, starting at 20.00 UTC.

## 7. Any other business

We discussed a proposal from Arjun for a Global Dance day for peace, maybe in October. We may not decide that DUP IN will sponsor this, although we could advertise this; it was agreed to keep this suggestion open for the next meeting. We felt this was best offered/facilitated by Arjun as an individual, rather than sponsored by our BoD, but we left open the question that was raised about how we can find ways to keep rapport flowing between leaders and the organisation.

The meeting closed at 23.15 UTC.
