Comments:

• our closing balance at the end of 2019 is \$4775 higher than at the end of 2018; this is despite not drawing down any prior revenue to fund Beyond, because the Beyond initiative was funded by significant unbudgeted donations.

Excluding the money allocated to Beyond, our closing balance would be \$51,113.96. This is \$2262.24 higher than the corresponding prior year closing balance. In other respects, costs and revenues were broadly as budgeted.
