#### **BOARD MEETING MINUTES**

#### Welcome

Board agrees to dispense with the check-in.

#### Approve Minutes of the 9 March telecon

Halima moves, Allaudin seconds, that the minutes of the 9 March 2010 telecon be approved for distribution. Passes unanimously.

#### Financial Report: 2010 Year to Date and Balance Sheet

Munir and Kabir are making some adjustments to the first quarter report, and will present it at the next meeting. The finances look as expected for this point in the year.

#### **Possible Name Change**

Munir had asked Board members for suggestions for names for the corporation; subsequent conversations with regional representatives seem to indicate that a name change is timely. The Regions task group proposes a name change because the name issue is central to our communications strategy with Regions and others. They feel that the name "PeaceWorks" is confusing, is used by many other organizations, and does not reflect our mission. "Dances of Universal Peace" is too long for use in an organization name, so it tends to get abbreviated, and the resulting acronyms are not appealing.

The task group recommends that:

- 1) a decision on the new organizational name be made in the near future, and
- 2) the Board consider the names "Peace Dance International", "Peaceworks International," "Dances of Universal Peace International" and "Dancing Peace International".
- 3) begin by posting the names as proposals on our website and inviting comments and inspiration, and then review the input at our May Board meeting and decide next steps.

The post on the website will include an introductory paragraph explaining that this is only a change to the name of the organization, that we will always be international network for the Dances of Universal Peace, so that there is no confusion or consternation among members.

Allaudin moves, Darvesha seconds, that the Board approve this recommendation. Passes unanimously.

#### Web Sites Update

Munir continues to update and develop the old web site. Work continues on the new website; Munir is hoping to have a conference call soon with Halima, Patsy Boyer and Bruce Heeter to move ahead.

#### Communications, Dues, Draft Regions Policy

Munir, Kabir and Allaudin (the Regions task group) have drafted a revised Regions Policy which is a description of what a region might be, rather than a prescriptive policy of a region has to be; their thinking is that regions develop organically and from a grassroots level.

This is part of the process of determining what Leaders Guild dues and regional policies are about. Munir adds that we need to communicate immediately with the regions on this and some other key items, including dues and fiscal year accounting related to that.

Halima asks how this would be reviewed by people who are not in a region? An email to the Leaders Guild would take care of that, and Munir plans to send a quarterly email communication to the Leaders Guild soon. Board discussed the use of the In-the-Garden Yahoo group, which is for all mentored leaders, and the DancingPeace Yahoo group, which is for anyone in the Dances of Universal Peace Network worldwide, in addition to sending an email to all members of the Leaders Guild using our own database of contact information. Halima and Darvesha agreed that the email about the new regions policy should go to In-the-Garden, with an announcement to DancingPeace asking all leaders to join In-the-Garden, which is the appropriate forum for discussion of Leaders Guild announcements. Darvesha adds that posting it on the South American listserve in English will be fine; they will find their own translators for this, and the MTG guidelines are the main translation project right now.

Kabir asks if this really needs to be reviewed with people who are not in a region at this point, that the main input needs to come from already existing regions. Halima cautions against forming a closed loop and the need to include people who are not in regions.

Kabir moves, Allaudin seconds, that the Board approves the task group taking this to regional representatives for feedback, after a bit is added to the policy about local languages and cultures. Passes unanimously. (Revised draft attached.)

Munir has been having Skype conversations with regional and geographic representatives in Russia, Switzerland, Germany and Australia, to clarify relationships, address issues and determine next steps. He has also contacted representatives in France and has not received a reply yet. A communication with representatives from the Netherlands is planned.

Some of the comments and questions from the Russian conversation were about the scarcity of Dance mentors in Russia; Halima would like the Guidance Council to take that on.

#### **MTG Guidelines**

Since the last meeting Kabir has updated the .pdf version by comparing it for accuracy with the on-line version, adding a cover page, numbering and formatting for two sided, bound printing.

He and Munir feel it would be appropriate for an MTG member to be asked to be the "keeper of the guidelines". This person could receive all updates or changes to the guidelines and produce a version that can be used to update periodically (annually?) future editions of the guidelines for the website and .pdf. This is especially important since changes to the guidelines will also need to be translated. *Action item: Darvesha will take this on; Kabir will work with her on this.* 

#### **ANNUAL MEETING MINUTES**

#### **Election of Directors**

Allaudin moves, Halima seconds, that the following slate of directors be accepted for Peaceworks International. Passes unanimously.

Munir adds that he has spoken with Pir Shabda Kahn who is unable to be at the annual meeting but is very supportive of the work of the Board. Shabda, a member of the former Advisory Committee, said he supports both the slate and the new procedure for electing the officers and board.

#### **Determination of the number of Directors**

The board discussed the possibility of expanding the number of directors to seven sometime over the next year, and consider the addition of international representation.

Halima moves, Maitreya seconds, that Board increase the number of directors to seven with the understanding that vacancies will remain unfilled until suitable opportunities arise. Passes unanimously.

#### **Determination of Officers**

Halima moves, Maitreya seconds, that the interim officers be elected as officers. Passes unanimously. The officers for Peaceworks International are:

Darvesha MacDonald, President Allaudin Sandy Hill, Vice President Kabir Stuart McKinnon, Treasurer/Secretary

#### **Executive Director Title**

Kabir moves, Allaudin seconds, that Munir's title as "Director", as listed in the Unity Council recommendations, be changed to "Executive Director". Passes unanimously.

#### Financial Reports: 2009 Year End P&L and Balance Sheet

Kabir presented the financial reports for Peaceworks International. The "gross profit" of \$44,000 in 2008 reduces to \$11,000 in 2009 because of the sale and inventory reduction of Peaceworks Pubs items through which we incurred substantial cost of goods sold expenses.

Kabir noted that we have approximately \$69,000 in cash reserves, which is a healthy position to be in for the upcoming years. However, some funds included in this total were designated as restricted in prior years and research is needed on these items to see whether there are any items for which the restrictions cannot be changed by the board.

Although the finances are a little tight right now, there is much support for the work of the Board and the organization, and as leaders begin paying their guild fees, the income will go up.

These reports are included as Appendix 2.

#### APPENDIX 1: DRAFT REGION POLICY

# PeaceWorks International Center for the Dances of Universal Peace <u>Dance Regions</u>

#### The Mission of PeaceWorks (PW) is:

To cultivate excellence and spiritual depth in leading the Dances of Universal Peace and Walking Meditations by supporting the work of the Mentor Teachers Guild in guiding the Leaders Guild. PW also links the worldwide community of participants in the Dances.

As the administrative and fiscal arm of the Mentor Teachers Guild (MTG), PW extends support to mentors and leaders throughout the world wherever the Dances of Universal Peace are organized. PW also maintains an interactive website in several languages, which is its principal vehicle for linking the worldwide community of participants in the Dances.

#### Regions

In many parts of the world, regional dance organizations (Regions) have emerged over the years through which leaders and dancers in a particular area can create a more active local network, pooling resources to foster the growth and expression of the Dances their communities. Regions can link people and provide information and ideas in their local

language, using communication tools like web sites, email, journals, and periodic regional meetings and teleconferences. They can also facilitate co-operative ventures such as regional dance retreats, trainings and camps, and provide resources to assist those who organize and publicize individual dance circles. All of this can be accomplished in ways best suited to applicable cultural factors.

A Region can be created wherever the dance leaders in a locality decide that this would be advantageous. Experience has shown that for a Region to function successfully and sustain itself over the years a "critical mass" of mentors, dance leaders, dancers, and dance circles is required. Members of the leadership group of a Region need to learn and practice skills such as consensus-building, goal-setting, program planning and budgeting, as well as skillfully resolving conflicts that may arise.

#### Relations between Regions and PW

Prior to 2010, Regions were created under the auspices of PW. This is no longer the case. Regions are now completely autonomous entities created and governed locally.

Regions are free to finance themselves as they see fit. Many have adopted a membership basis in which leaders and dancers join the Region and contribute through annual membership dues. Another model is annual contributions from all dance circles in the Region.

While Regions are autonomous entities, they are encouraged to maintain an active relationship with PW to ensure coordination of programs and services and effective use of resources. It can be helpful in this regard for a Region's leadership group to designate one of its members as a PW contact person — a function carried out by Regional Networkers in the former structure. PW maintains an active communication program with the leadership of each Region, including e-newsletters as well as periodic conference telephone calls.

#### **Collection of Leaders Guild Fees**

One of the functions of PW, on behalf of the MTG, is supporting and maintaining the Leaders Guild. The Leaders Guild consists of the entire body of mentored leaders of the Dances of Universal Peace who been acknowledged by the MTG (at various levels, including mentors) and have agreed to uphold the MTG Guidelines. All dance leaders are expected to remain current with their annual Leaders Guild fees, which are collected by PW. Leaders Guild fees are the means through which the work of the MTG, and in particular the MTG Guidance Council, can be sustained.

Many Regions have agreed with PW to collect and remit the applicable annual Leaders Guild fees for all <u>leaders</u> in their Region. (Note: Dancers other than leaders do not pay Leaders Guild fees.) These fees are completely separate from any dues collected by Regions for local use. PW encourages and appreciates this assistance from Regions where mutually acceptable arrangements can be made. Otherwise, PW collects Leaders Guild fees directly from each dance leader.
