Annual Meeting

Munir commented that the results for the first quarter are generally in line with expectations and with the budget established by the Board. The 2015 budget implements all of the Planning Committee recommendations except the 20% increase in Leaders Guild fees, which takes effect January 1, 2016.

Zarifah asked about the figure of \$9,760 shown in a note on the statement as "Receivable" Leaders Guild fees. Munir explained that some Regions collect Leaders Guild Fees on behalf of DUP International and then remit them periodically in lump sum payments. The figure is an estimate prepared by Martha of the amounts already collected by Regions but not yet transferred to DUP IN. The figure of \$13,766.10 includes the anticipated payment of \$9,760 that has not yet been received. In further discussion, Kabir commented that it is helpful to have some idea of receivable Leaders Guild fees in addition to fees already deposited, if staff have those estimates. It was suggested, however, that the financial statements include only amounts actually received.

3. Executive Director's Report

Munir reported that the April 2015 Leaders Guild e-newsletter was distributed the week of April 20, 2015 in English, Spanish, German, Russian and Dutch. The e-newsletter included the revised Mentoring Path guidelines, updated by the Guidance Council earlier this year. He has also replaced the old mentoring guidelines on the website in English, Russian, German, Spanish and Dutch.

DUP International's Fund for 2015 fund drive stands at \$18,724, which includes an anonymous gift of \$1,000 which we were just notified of. Munir is continuing to work with prospects who

offered to give in 2015 to complete the drive. An update will soon be sent to donors on the progress of the drive. Very recently a past donor offered to help make up some of the balance needed, so Munir is hopeful that we will complete this drive soon.

Work in progress includes an abbreviated version of http://dancesofuniversalpeace.org in Dutch. Malika Cieremans is doing the translation for us. The Dutch website will include a log-in for Dutch-speaking leaders. Munir hopes to have this on line and appearing in the language menu by the end of May. The Leaders Guidelines were translated into Dutch and distributed to the Dutch leaders in late 2014.

Munir is continuing to work with our tech consultant Bruce Heeter on an across-the-board banner and color scheme change to all of the websites. He hopes to have this completed by the end of the summer.

Many thanks to Munir and Martha for their dedication and skill that delivers such high quality services to Leaders Guild members worldwide!

4. Guidance Council Report

The Guidance Council was busy at work over the holidays and into 2015 revising the Mentoring Path Guidelines and adding some additional text to the Leaders Guidelines. The Mentoring Path was revised to combine Senior Mentors II and III into simply "senior mentor" category. The Senior Mentor III function is now covered by the Guidance Council.

Language was added clarifying that mentoring is a separate path from that of the dance leader. Consequently, additional language on Deepening in Dance Leadership is created for the Leaders Guidelines that clarifies expectations for the development of the Dance leader after certification. A copy of the new Deepening in Dance Leadership wording was shared with the Board for information. It will be published by the Guidance Council at a later date.

5. Communications Committee Report

The Communications Committee (Arjun, Chair; Rashid Andrew Hall, Aziz Edmund Dixon and Munir) provided notes from its first two meetings. In the first meeting members got acquainted and reviewed the purpose of the committee. Between the first and second meetings the members prepared and shared reports on the activities of the Dances of Universal Peace within the regions with which they were familiar. In the second meeting the committee discussed two questions:

- 1. What is my vision for our shared work? The best service we can offer? What can we actually achieve? and
- 2. On the practical level, how much time do I have?

The Committee is still defining its objectives and the project(s) it may wish to pursue. A third meeting took place a few days ago, following which Aziz advised that he has decided to withdraw.

Munir commented that the Committee's task is complicated by the Board's decision to combine the "communications committee" and "worldwide network committee" envisioned in the Planning Committee report. The potential scope is quite broad, and it is not yet clear where the group will determine is the most useful focus for its efforts.

Darvesha noted that there is some indication in the Committee's notes that DUP IN needs to improve its communications, leading her to wonder how we know that this is the case, what this assumption is based on.

Arjun commented that, in his experience, there is always room for improvement. He felt that a few more Committee meetings would help shed light on this and other matters.

Kabir recalled that the need to provide focus and leadership through what has become the communications committee was identified by the Planning Committee. In the formative years of DUP International, the Board and staff have not until now had the resources to give attention in depth to these matters. We have maintained and in some cases expanded programs and services that were in existence when we began five years ago, but we have also been aware that many conditions have changed during the life of the international Dance organization, notably the web and related technology. It seemed important to the Planning Committee to take a fresh look at communications and the worldwide network so that our future plans can be based on a better understanding of current and emerging needs. Kabir agreed that the mandate of the Communications Committee is broad and possibly vague, but this seems unavoidable until the Committee has had an opportunity to investigate and reflect.

Zarifah commented that the communications are at the core of the work of the Board. She welcomes what will come from people taking the time to study the issues and possibilities. Munir and Darvesha both agreed with this observation. Darvesha recalled previous inquiries of a similar nature, for example the work of the Dance Unity Council through which the international organization redefined itself as a web-based service provider rather than a physical office. She added that the topic of "regions" can be a quagmire.

Rashid agreed with Arjun's sense that communications can always be improved. There are multiple directions in which communication could occur, including from the Center to the Circle (of dancers and dance leaders), from the Circle to the Center, and between different points in the Circle (Circle to Circle). It may take some time to reach clarity.

Maris echoed Darvesha's comments about regions. She added that she imagines some developments through modern technology, for example making the Resource Library more friendly to mobile devices, which could provide a welcome new tool for Dance leaders.

Munir suggested that Communications Committee meetings be open to interested Board members, noting that the next scheduled date is May 14 at 3 pm Mountain Time.

Arjun wondered whether the Board was perhaps providing the Committee with an unclear mandate. If so, a lot of work might be done and then be rejected by the Board because it is not what was wanted. Darvesha clarified that the purpose of the Committee's work at this point is exploration: the Board is asking questions without any idea what the answers may be. Kabir expressed confidence in the Committee and the process, and offered to be available when called upon, should this be of service.

6. Welcome Rashid and Zarifah

Rashid and Zarifah were welcomed to the Board and invited to comment on their observations and aspirations as they enter into service in this way. Maris expressed gratitude to all those who have served as Board members over the years.
