Munir outlined the proposed budget, noting that it was based on continuing at the same level as the current year's budget, with only minor adjustments. Kabir added that, in reviewing the figures with Munir and Zarifah prior to the meeting, he had noted a considerable gap between forecast fee revenues and the potential fee revenue from 1,200 Leaders Guild members @ USD\$36 per person. Taking into account the fee support program, the gap is approximately \$10,000. While supporting the budget, Kabir suggested that the Board look into the conditions that have led to this result. Munir commented that there are particular histories and factors that need to be understood. Kabir added his appreciation for Arjun's offer by email to take a look at the Latin American numbers to see if he can find clues and/or patterns. Rashid offered to do something similar for his part of the world, and Munir responded that the rate of payment is generally strong in Australasia.

The Board then turned attention to the proposed 2016 Goals and Activities:

1. Continue to implement the organization development plan put forward in 2014

- 2. Add one new member to the DUP International Board of Directors
- 3. Complete succession plan for Executive Director, including orientation and support for the new person.
- 4. Implement the Leaders Guild Fee increase to \$36 that begins in 2016; this includes special billing to those with recurring fee payments to have them cancel existing payment of \$30 and create a new payment of \$36
- 5. Continue to build leader resources on the website in all supported languages. This could include adding Dance write ups to the German and Dutch websites, completing the German Foundation Dances and Walks manual

Kabir moved, seconded by Rashid, that the Board of Directors approve the proposed 2016 Budget, Goals and Activities. Carried unanimously.

The following list of Key accomplishments in 2015 was received for information:

- Continued implementation of multi-year financial plan developed in 2014.
- Redesigned <a href="http://dancesofuniversalpeace.org">http://dancesofuniversalpeace.org</a> in a new color format and banner with revised language menus.
- Translated and added a Dutch language version of the website. The website is now on line in English, Spanish, German, Russian and Dutch.
- Added 36 Dance write-ups to the English Dance Library.
- Provided fee support to 61 leaders who had financial hardship in paying their Leaders Guild fees.
- Produced, translated and distributed the revised Mentoring guidelines, two e-newsletters and one new Elements of Mastery article in English, Spanish, German, Russian and Dutch. All items were also published to the DUP International Facebook page.
- Completed editing and reformatting of the Spanish language Foundation Dances and Walks Manual and published it to the Spanish language library.
- Held three telecom meetings of the DUP International Board of Directors, four meetings of the communications committee and five meetings of the administrative committee.
- Partially funded and held one in-body meeting of the Guidance Council in conjunction with the Jamiat Khas with Pir Shabda Khan and Murshid Saadi Neil Douglas-Klotz also in attendance.
- Reprogramed the fee payment page to allow contributions to be made at the time Leaders Guild fees are paid.
- Added a form for name of leader and mentor to the fee payment page.
- Established a Dances of Universal Peace International Facebook Group and began building membership.
- Added a column to display the category level of mentees in the report which mentors access within the My Info section of the IN website.

#### 4. Executive Director Search Committee Report

Darvesha reported that the search committee (Kabir, Maris, Munir and herself) has received eight applications for the position and determined a short list of two, both of whom have now been interviewed. The committee is coming close to concluding its work and recommending a candidate for appointment by the Board. The quality of applicants has been very strong.

The next step in the process will be to consult with the Guidance Council and Pir Shabda in order to be sure that they are comfortable with the search committee's recommendation. Assuming so, the search committee will write its report and recommendation to the Board. If Board members are prepared to act on this matter in a vote by email, that can happen, and alternatively if any Board member has a preference to convene a special meeting, that will be arranged.

Munir expressed his appreciation to Board members for the Pendleton blanket that was presented to him during the Jamiat Khas retreat.

## 5. Facebook Group Administration

Following the Board's discussion at its September meeting, Munir created a new Facebook Group for DUP International, which now has more than 600 members. Rashid, Munir, Kabir, Arjun and Darvesha have corresponded about issues in administering the group, including whether event postings are welcome (yes) and whether merchandise can be offered for sale (no). Initially, the group was open to member posts, but through discussion, it was decided to name a moderator to vet submissions. Rashid agreed to serve in that role, and created a private DUPI Group Admin group, also on Facebook, to facilitate discussions among the administrator group.

Rashid commented that the group has been going well, with the back-and-forth discussions generating useful guidelines and outcomes. He is happy to continue as moderator, if that is the wish of the Board. He expressed appreciation to Munir for the back-up service when Rashid was away recently, and pointed out that this need will be a continuing one.

Rashid also mentioned that participation seems quite strong from North America, Australasia and to some extent Latin America, but not as yet from Europe. He encouraged people with contacts in Europe to promote the sharing of events in that region as a means of stimulating awareness and participation.

There was brief discussion of the request to post information about the Murshid SAM Biography project, which is seeking funds, and a clear sense that this request is appropriate and quite different from personal requests to sell products.

Zarifah asked about whether the guidelines for the group have been published. Rashid pointed out the group description, pinned to the top of the page, but acknowledged that there are issues that have not yet been clarified to the extent of becoming written guidelines. The moderator's role is an active one, requiring discretion.

Darvesha suggested that Rashid be empowered to make all necessary decisions, and that he continue to be supported by a small administrative group that can be consulted as need be. There seemed to be agreement with this suggestion. Zarifah accepted Rashid's invitation to be added to the group of administrators.

#### 6. Guidance Council Report

The Guidance Council held an in-body meeting on Saturday, November 8, 2015 at the Jamiat Khas gathering in Petaluma, California. Present were Darvesha, Munir, Saadi, Halima and Farrunnissa. Discussion largely centered on the work of the search committee to find Munir's replacement as Executive Director. Munir outlined several matters before the new director, including implementing the Leaders Guild fees increase to \$36 beginning in 2016, promulgating

the changes to the Leaders Guidelines now being completed, and completing the German language Foundation and Walks Manual and the German dance library.

## 7. Executive Director's Report

- a) The fall newsletter has been emailed in English, Spanish, German, Dutch and Russian.
- b) Martha and I are working with our first batch of leaders receiving billing for January 1, 2016, in which Leaders Guild fees increase to \$36. Those with existing recurring payments of \$30/year will receive a special invoice with instructions on how to cancel their existing PayPal recurring dues payment and create a new one for \$36 annually.
- c) I am working on a "handbook" for the new Executive Director containing my contacts and key information on software, procedures, etc.

#### 8. Meeting Dates for 2016

The Board decided to await the appointment of the new Executive Director before setting its quarterly meeting dates for 2016.
