## 1. Minutes of the Board Meeting held September 26, 2017

Munir moved acceptance of the minutes, seconded by Munira, approved unanimously.

### 2. 2017 Financial Reports: to end of October 2017

### ED comments:

The financial outcome compared to budget remains positive.

- in addition to the \$17,100 legacy, we have received an anonymous donation of \$2,000, and other donations totaling \$3,782 (compared to a budget of \$3,500). It was agreed to report on the legacy separately from recurrent finances.
- LG fees- regions: on the balance sheet, accounts receivables, we see an estimated \$5,400 still to come from Germany. Thus we will be within budget for Fees regions by the end of the year.
- No further web (tech designer) costs have been received since the last meeting, but these may be expected by year-end.
- net income derives from the legacy plus a surplus of \$3,459, with some revenue and some costs still to come in November, December.

# Community Co-ordinator:

With Martha's much appreciated help, I have got to know this role. In anticipation of the yearend Leaders Guild statistics (ie number of leaders), we have followed up all leaders who may need fee support renewal, or end-dating (if their payments lapsed or they never paid). This has been approached partly direct with leaders, and partly via mentors, or by country. Communication with the Bosnian family has improved, thanks in part to help from German mentors. In Eastern Europe and Latin America we have been able to gather further information on leaders' first languages and fluency in English where relevant.

This follow-up process has also helped to refresh our contact list for each country.

### Other activities:

- I am working to update the contact listings for each country.
- Dakini has found a French translator, and I am exploring priorities for this work (eg key website pages, SAM dances, Leader Guidelines).
- dance write-ups: we have initiated translation of some of the most popular dances into all languages, but further work on the considerable collection of write-ups is likely to resume after the Board meeting.
- Budget 2018: I will prepare a budget when we have year-end figures at the turn of the year.
- No newsletter is in preparation just now.

Noted in discussion: we will continue to ask for mobile phone numbers, as these may become more important in future.

## 4. Guidance Council report

Wali Ali has raised the topic of the  $50^{th}$  anniversary of the origination of the Dances in 2018. Guidance Council will oversee plans for this.
